Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with applicable Schedules of said regulation, we would like to inform about the Hon'ble High Court of Allahabad order dated 21st July, 2025 received by the company on a writ petition filed against SBEC Sugar Mills in relation to outstanding cane dues of crushing season 2024-25.

The Hon'ble High Court of Allahabad has directed The Collector, District Baghphat to execute recovery certificate against the company in accordance with law within a period of two months from the date a true attested copy of the order is placed before the Collector, District Baghphat. Once the amount covered by the recovery citation/certificate is realised, the claim of petitioners shall be settled without any delay as per the norms that are being followed by respondent no.5 (i.e. Sahkari Ganna Samiti, Baghpat).
